Purchase order no. 15 (S&P) dated 30.09.2019 for supply of 26.60 MT of DPC Al. winding wires of different size 1.15 mm, 1.25 mm, 1.32 mm, 1.4 mm, 1.5 mm, 1.6 mm, 1.9 mm & 2.0 mm & Strips for repairing of distribution transformer of 25 kVA, 63 kVA, 100 kVA & 200 kVA under ADP Head was placed upon your firm. As per clause no. 7(Delivery Schedule), your firm was required to supply the materials as per below mentioned amended delivery schedule:-

Order qty.	1st month	2 nd month
Monthly delivery schedule for order quantity i.e. 26.60 MT	Nil	26.60 MT

Even beyond the contractual delivery schedule of said P.O and in spite of consistent follow up by this office, your firm miserably failed to supply the order quantity in totality. Several reminders were also served to your firm by this office but no positive response have elicited from your end. Your firm has adopted unethical business practice by not supplying the ordered quantity in confirmation with P.O and misled JBVNL by assuring to supply the said materials on different dates, but failed to do so even after final notice.

From above position and facts, it is clear that even after constant perusal, your firm did not come forward for supply of any quantity against awarded purchase order. Thus it \hat{O} is quite evident that your firm has failed miserably to fulfill its contractual obligation under the said purchase order.

Accordingly, the facts & status was analysed by JBVNL and it has been decided to short close purchase order no. 15 (S&P) dated 30.09.2019 and forfeit the Bank Guarantee or amount deposited against said POs. Also, your firm M/s Sitara Conductors & Cable Private Limited, PO & Vill Bhelal Pahari, PS -MGM, Jamshedpur -831012 is being here by debarred for period of one year (from the date of issuance of communication) in JBVNL.
