PUBLIC NOTICE

Objections / Comments invited from various stakeholders on the Petition submitted by JBVNL seeking approval of the Commission on Principal PPA dated 23.02.2012 and Supplementary PPA dated 22.04.2013 signed between JBVNL and Inland Power Limited (IPL)

M/s Inland Power Ltd had signed a MoU with Govt. of Jharkhand on 18.10.2011 for setting up a 126 MW (2 x 63 MW) thermal power station named as Inland Gola Thermal Power Project, located at Inland Nagar, Block Gola, District Ramgarh, Jharkhand on a build, own and operate basis. As per the MoU, the Govt. of Jharkhand or distribution licensees authorized by it will have the first right of claim of purchase up to 25% of power delivered to the system under terms of a PPA. Out of the 25%, the tariff of 13% share will be as approved by JSERC and balance 12% will be delivered on variable cost. IPL will have the right to sell the balance power outside the state of Jharkhand.

Pursuant to aforesaid MoU, a power purchase agreement (PPA) was signed between Jharkhand Bijli Vitran Nigam Limited (erstwhile JSEB) and Inland Power Ltd on 23.02.2012 (hereinafter referred as the Principal PPA) for the purchase of 35 MW from the 63 MW of the 2 X 63 MW thermal power station. A Supplementary PPA was signed between JBVNL and IPL on 22.04. 2013 for purchase and sale of entire quantity of power to be generated from 1st unit of 63 MW.

JBVNL has filed a petition before the Commission for seeking approval of the PPA(s) dated 23.02.2012 and 22.04.2013 signed by it with IPL.

- 1. The Commission has directed JBVNL to invite comments/suggestions from the public on the above Petition/ PPA(s) through this Notice.
- 2. It is to be noted that if the sender wants to be heard in person, the opportunity would be given by the Commission at the Public Hearing, for which date and place shall be announced by the Commission separately.

JBVNL shall reply to each of the objections/comments/ suggestions received within seven days of the receipt of the same but not later than 27/06/2018 for all the objections and comments/suggestions received till 19/06/2018. Stakeholders can submit their rejoinders on replies provided by JBVNL either during the public hearing or latest by 04/07/2018.
